TO: The U.S. Senate, U.S. Congress, U.S. Supreme Court & U.S. Executive Brach

FROM: We the People (penned by Reid Reasor)

Comply with the United States Constitution (the supreme law of the land) and restore the illegally taken inalienable Bill or Rights to avoid historical atrocities (Leach et al, 2013) (Ragsdale, 2000) (Staub, 2012).

The U.S. Constitution Article V requires a ratification process in order to change the scope and enumerated powers of the U.S. federal government. The 10<sup>th</sup> amendment specifies that all powers and rights not yielded by ratification processes are reserved for the states or We the People (Rosenkranz, 2011) (Bouton, 2014). To date, there has been no state ratification effort for any federal violations of our inalienable Bill of Rights.

Current actions of the U.S. federal government constantly violate our fully articulated, legally vetted human rights with centuries of legal precedent (Rosenkranz, 2011). Here are just a few:

- 1. Department of Justice (DOJ) illegally wire tapped the Associated Press (AP) gathering two months of e-mails, illegally confiscated an American Broadcasting Company (ABC) computer and written records, and then arrested a Fox news reporter. These actions violate the 1<sup>st</sup> amendment freedom of the press.
- 2. National Security Agency (NSA) is constantly collecting our cell phone signals, cell phone images, e-mails, land line conversations and with other classified collection means gathering private information without probable cause to any specific individual or describing any of the items to be searched for and seized. These actions violate the 4<sup>th</sup> amendment unreasonable search and seizure.
- 3. On September 30<sup>th</sup>, 2011 the U.S. Commander and Chief directed a drone strike against the sixteen year old minor American citizen Abdulrahman al-Awlak who was looking for his father overseas. Two weeks prior, U.S. drones killed Abdulrahman's father Anwar al-Awlaki and his partner Samir Khan. These killings were not on any battlefield and the killings violated their 5<sup>th</sup> amendment rights ensuring no deprivation of life or liberty without due process of law.
- 4. The National Defense Authorization Act (NDAA) authorizes U.S. federal agencies to indefinitely detain American citizens without a trial or legal representation. This act directly violates the 6<sup>th</sup> amendment provision of a speedy trail and the 5<sup>th</sup> amendment of deprivation of liberty without due process.

Those who have illegally taken our rights have made a common historical error in judgment. They believe they have a pressing need to take action combined with better intelligence, better moral judgment, better education and better situational awareness than

the Founders or We the People. They believe they are so right, that they are justified in illegally taking our human rights. According to President Woodrow Wilson, "The government does now whatever experience permits or the times demand (Pestritto, 2005)." The U.S. Senate in November, 2014 rejected S. 2685 (USA FREEDOM Act of 2014) that would have restored some of our lost liberties; our federal representatives have no intention of ever fully giving back what they have illegally taken.

Some citizens believe tyrannical actions are required for the security of our nation (Watson, 2015) these people however have failed to accomplish a historical review of the long term consequences of the surveillance state on the population or the illegal manner in how these powers were openly taken 13 years ago (Ragsdale, 2000). Historically, governments start tyranny with promised provisions of security, safety and prosperity while taking the human rights of their people (The Death of Freedom, 2006). Every nation that has taken the provisions of the 1<sup>st</sup>, 4<sup>th</sup>, 5<sup>th</sup> and 6<sup>th</sup> amendments have all eventually murdered there own people (Leach et al, 2013) (Ragsdale, 2000) (Staub, 2012). The government's first job is not security, but lawful self obedience. Some citizens advocate the immediate removal of all our rights for global control and desire end-state solutions similar to Stalin, Moa, Leopold and Pol Pot, "for the greater good." They believe that they then would get to decide what is "good" as well as the means of achieving the "greater good." These people and the federal government may not "redefine liberty" ... that role is reserved for We the People. This concept is exactly why America was founded, and what our Constitution expressly prohibits (Bouton, 2014).

Beginning with the American Revolution in 1775, over 1,320,260 U.S. veterans have fought and died for the establishment and protection of the U.S. Constitution and our rights (2014, December 28). The question is not how many lives can be saved using tyranny, but how many lives have been shed to prevent it. The U.S. Constitution is the most foreign studied government document in the history of the world (Rosenkranz, 2011) (Billias, 1990). It has been used by over 170 different nations to establish a baseline of liberty and the standard for freedom around the world (Billias, 1990).

We the People demand the federal government comply with the supreme law of the land (The U.S. Constitution) and immediately stop all violations of every provision outlined in our inalienable Bill of Rights.

## We the People should:

- 1. Review the U.S. Constitution and our inalienable Bill of Rights and help educate others about the supreme law of the land and the consequences to world liberty if we are compromised or destroyed.
- 2. Protest the U.S. Supreme Court's decision to not hear or rule on the constitutionality of NSA spying or the NDAA provision of indefinite detention.
- 3. Refuse to comply with any and all actions of every agency that violate our fully outlines and documented human rights.
- 4. Contact your federal house representative and federal senators and demand the passage of laws restoring all of our rights.

- 5. Contact your state representative and state senators and urge the passage of state legislative nullification actions of all U.S. federal unconstitutional acts (see attachment 1 for a draft from the Texas legislature).
- 6. Financially contribute to liberty and privacy organizations that are fighting the federal illegal actions in court.
- 7. Contact your country sheriff, local magistrate or local prosecutor and ask for a criminal investigation into your federal representative and federal senators who have illegally taken the inalienable Bill of Rights (see attachment 2). They should be investigated and prosecuted as their offices have no power to take our rights. These federal employees should be considered domestic threats to the U.S. Constitution.

If by July 4<sup>th</sup>, 2017 all of our human rights are not restored, it will then be apparent that We the People have failed to win legislatively or legally against the forces that want to continue to advance tyranny. Our federal government will then continue to illegally assert their powers to violate our liberties by surveillance, removal of due process, indefinite imprisonment and even death of American citizens.

Therefore, on July 4<sup>th</sup>, 2017, because of 15 years of openly continued illegal violations of the U.S. Constitution and our inalienable rights, We the People declare a formal state of conflict will exist against the government instruments of oppression. Use of non-lethal force against the means, infrastructure, support and instruments of oppression is justified until our rights are restored.

This is not a political issue, gender issue or racial issue. It is a basic freedom of humanity issue. The founders defined it and We the People have backed it with centuries of legally precedence and selfless sacrifice. The federal government is on an illegal road to tyranny with the end state having historical, deadly certainty. Some unscrupulous powerful people are counting on this dreadful end state for world power and control. These skilled enemies are intentionally trying to remove our freedoms and the expectation of freedom from future generations.

If fear of government restitutions, harassment, arrest and imprisonment are normal when exercising our documented rights ... then we are slaves.

If We the People do not force the return of our rights, they will be gone forever. The most important civil rights fight of this generation is the return of liberty to the most generous, most selfless nation the world has ever seen (Bennett, 2011) (Sinclair, 1975).
